## 9. Discussion on the Future of ALARA

**MRM email comment -** I appreciate the plans for a 2019 ALARA event in Australia, or a 2020 conference in Australia - I think this is important as the ALARA networks has relied heavily on personal networks and recommendations and this is hard to achieve in a competitive global context. Thinking about CD/networking principles, is it possible to align more closely with the functioning group of Brisbane or the other geographic/relational spaces ALARA inhabit, and grow out again from there?

There were 3 comments made on the electronic survey. These included:

• Could not access annual reports.

The meeting discussed this issue and agreed to identify the browser these members were using as this may be part of the problem. We will also send these members a copy of the reports.

• I cannot access the Auditor's report. The link results in a page not found message so I've abstained from the last two items. Regarding the losses from the Congress, what have been the lessons learned for the future?

There was no clear reason for the low numbers at the Congress. Perhaps it could have been the ARNA conference being held a week later. Vermont was also difficult to get to by air. Those who attended from the USA were within driving distance of Norwich. A good relationship was established with Norwich University. This lesson suggests that in future we need to ensure that there is easy plane access to where the event is being held and it will guide the location of the joint conference to be held with CARN in Europe in 2019.

- Thank you to the Committee and President for your ongoing hard work to keep ALARA moving forward.
- Robyn Lynn asked how ALARA will move forward in relation to its financial situation.

  Colin Bradley advised that ALARA is moving towards transitioning to a company with a view to developing partnerships and sponsorships to build the financial situation of ALARA. As a company limited by guarantee, ALARA could seek philanthropic funds. There is also the idea from Michelle about building local chapters. However we do need more people on the Management Committee to build the local chapters.
- Winston suggested organising some Webinars. The Zoom software would allow this to happen and to share what ALARA has done. However we need 1 or 2 people to create the Webinars.
- Winston also suggested that the United Nations could be a source of funding under NGO's. Colin Bradley will look into this further.
